DIRECTOR OF AGRONOMY - POSITION OVERVIEW

The Director of Agronomy will oversee the strategic and day-to-day operations of our golf course maintenance and 94 acres, in addition to 20 acres of meticulously maintained landscapes around the Clubhouse that includes a separate grounds staff. The DOA is responsible for ensuring the golf course is in pristine condition, aligning with the high expectations of our member-owned facility. With the ongoing significant renovations and an upcoming reopening, the Director's leadership will be critical in maintaining and enhancing their reputation as one of the finest private clubs in the South.

INITIAL PRIORITIES OF THE NEW DIRECTOR OF AGRONOMY

- Work through any remaining punch list items from the renovation.
- Develop a plan for preparing the new turf areas to offer great playability and their first winter season.
- Embrace and learn about the golf course maintenance team and their culture.
- Create a cooperative professional relationship with other department heads.
- Working with the General Manager and Green Committee to understand expectations and Club culture.

RESPONSIBILITIES OF THE NEW DIRECTOR OF AGRONOMY

- Direct and manage the daily operations of the golf course maintenance and grounds staff.
- Maintain high-quality course conditions, meeting the expectations of the members.
- Keep detailed records of annual maintenance activities and costs.
- Prepare, input, and collaborate with the GM on annual operating and capital budgets.
- Keep the GM informed about maintenance issues and progress.
- Ensure compliance with all licensing requirements for pesticides, herbicides, and other chemicals as mandated in Louisiana.
- Supervises the efficient operation of an equipment service and repair shop.
- Providing adequate safety and protection of members, guests, and staff, ensuring compliance with all
 applicable codes of practice.
- Negotiate and manage contracts with vendors and contractors for services, equipment, and supplies.
- Oversee the selection and management of third-party services, ensuring quality and adherence to club standards.
- Conduct regular safety audits and training sessions for all agronomy staff.
- Lead regular team meetings to align goals, disseminate information, and foster a culture of continuous improvement.
- Establish quality control standards and regular assessment protocols to maintain the highest level of course appearance and playability.
- Monitor daily course conditions and adjust maintenance practices based on weather conditions and usage patterns.
- Manage training, salary placement, promotion, separation, and disciplinary action of GCM employees in cooperation with the HR Director.
- Works closely with the golf professional staff to ensure superior playing conditions.
- Attends monthly golf committee meetings.
